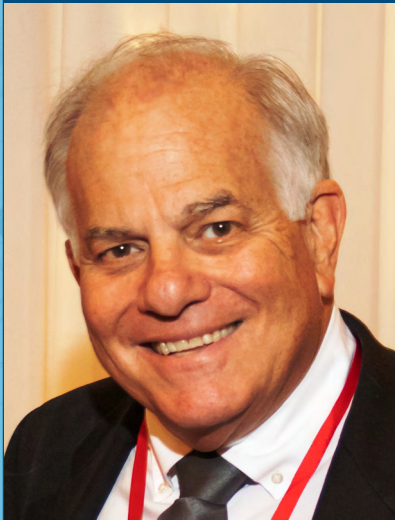

THE SHOMER TZEDEK AWARD (GUARDIAN OF RIGHTEOUSNESS) RECOGNIZES AN INDIVIDUAL WHO VALIDATES THE TENETS OF JUDAISM BY “GIVING BACK” TO THE COMMUNITY.
